Mr. Bass stated the purchase price of the vehicle would be \$56,291.00. Mr. Bass stated this is an approved budgeted item for the 2016 year for the Morgan County Fleet Department vehicle and purchase to be utilized as a service truck to be used in the field and the purchase will be made through John Elway Chevrolet.

**WHEREAS**, the County Commissioners have decided to restate the above-referenced Plan to comply with the requirements of the Pension Protection Act of 2006 (PPA), the Heroes Earnings Assistance and Relief Tax Act of 2008 (HEART Act), the Worker, Retiree, and Employer Recovery Act of 2008 (WRERA) and other applicable guidance.

NOW THEREFORE be it resolved by the Morgan County Board of County Commissioners as follows:

<u>Section 1</u>. The Plan is hereby restated and the Board approves the Chair to execute any required documents for the Plan's implementation.

Section 2. The County will act as administrator of the Plan and will be responsible for performing all actions necessary to carry out the administration of the Plan. At any time, the Commissioners may designate a person to perform the actions necessary to administer the Plan.

<u>Section</u> 3. A summary of the Plan provisions shall be provided to all Plan participants within a reasonable time following adoption of the Plan.
