WHEREAS, since the first County Sheriff was appointed in the year 1889, the Morgan County Sheriff's Office has provided law enforcement and other statutory duties to the citizens of Morgan County; and

WHEREAS, the Morgan County Sheriff's Office currently consists of fifty-five deputy sheriffs and support staff, along with ten volunteer personnel.

NOW, THEREFORE, BE IT RESOLVED, that the Morgan County Board of Commissioners recognizes National Police Week and commends not only the men and women of the Morgan County Sheriff's Office, but those also serving in the Log Lane Marshal's Office, Wiggins Police Department, Brush Police Department, Fort Morgan Police Department, Colorado Parks and Wildlife and Colorado State Patrol, for their commitment to provide law enforcement, safety and security to all residents of, and visitors to, Morgan County, Colorado.

Morgan County Sheriff Jim Crone presented to the Board for approval and recognition the Proclamation proclaiming the Week of May 15th thru 21st, 2016 Police Week. Sheriff Crone read the proclamation aloud. Sheriff

Crone provided a history of National Peace Officer's Week when President Kennedy was in office. He stated Morgan County currently has approximately 100 sworn officers who provide services for Morgan County. Currently, the Morgan County Sheriff's Department consists of 55 full time staff with about 10 volunteers. He stated that there were 129 law enforcement officers killed in the line of duty in the United States with several others who were injured resulting in being disabled during serving their communities. He commented about the loss of those this year in the State of Colorado and expressed his gratitude to the Commissioners for allowing this to be presented today. Commissioner McCracken provided a story when he first became a County Commissioner stating that he came upon a Sheriff's officer who was assisting a citizen in changing their tire, which is a positive reflection on the Sheriff's Department as well as the county overall and thanked all the officers for their duty and dedication to the County.

Commissioner McCracken made a motion to approve and recognize the Proclamation proclaiming the Week of May 15th thru the 21st, 2016 as Police Week as presented by Sheriff Crone. Chair Teague seconded the motion and motion carried 2-0.
