### MUNICIPAL SOLID WASTE LANDFILL

### 2018 DISPOSAL FEE SCHEDULE

**STANDARD FEES:** Municipal Solid Waste ONLY (MSW)

**MINIMUM FEE** - (Plus State User Fee\*\*) .....\$ **6.80**

**WEIGHABLE LOADS**

Standard Fees per Ton..... **35.10**

**MEASURABLE LOADS** (MSW) - When scale is inoperable (Includes State User Fee\*\*)

Dense Loads – shingles/cement/compact waste, etc per (Compact Cubic Yard)..... **10.50**

Loose Loads - normal household waste per (Non-Compact Cubic Yard) ..... **7.15**

**NON-MUNICIPAL SOLID WASTE** .....By Special Arrangement and Fee Negotiation

**OTHER FEES / CHARGES / SURCHARGES:**

Load PULL-OFF Charge .....\$**25.00**

Uncovered / Un-contained Loads..... **Cost will be DOUBLE**

Special Waste..... By Arrangement and Fee Negotiation may require **Special Waste Application**

Out Of County Waste ..... **\$10.00 per Ton Extra**

Mattresses ..... **\$2.00**

**MUNICIPAL SOLID WASTE EXCLUSION:**

(These Items must be disposed of in a Separate Area)

**If these Items are disposed of at the trash dumping area the charge is-- DOUBLE**

Tires - Car and Pickup..... \$ **3.00 each plus weight**

- Semi ..... **5.00 each plus weight**

- All Off Road (Tractor/Loader) ..... **25.00 each plus weight**

Vehicle Batteries..... **3.00 each plus weight**

(\*)FREON Appliances-Refrig/Freezers/Air Cond. etc ..... **15.00 each plus weight**

Old Fluorescent Light Ballasts ..... **3.00 each plus weight**

(\*)FREON Appliances - Must be placed in separate area and with no food or debris.

Additional Handling Fee will be assessed if they contain food or debris or IF

Dumped in trash area without Freon Removal Certification.

**All Non-TV Electronics will be charged at the regular trash weight, and will need to be placed in the Electronics Recycling Area.**

Televisions 32" and smaller ..... **\$15.00**

33" and larger ..... **\$35.00**

**RECYCLING – ( NO TRASH on load ):**

Clean Metal Only -**NO** wire/plastic/wood/cement/dirt/etc ..... No Charge

Tires Only ..... Regular Rate Each / Weight Fee Waived\*\*

**Special Burial / Handling** ..... 24 Hour Prior Notification Required, Fee based on equip. and time.

**Unacceptable Waste** - Persons delivering unacceptable waste will be held liable for costs associated with handling and/or removal of such waste.

\*\* **State User Fee is in addition to disposal fee – Effective January 1, 2016 \$1.17 per ton and \$0.35 per cubic yard** required on all waste disposal, subject to change per State regulation. Amount to be itemized on receipt.
