2. If you make a mistake, either request a replacement ballot from your County Clerk and Recorder, or cross-out any errors and add a note making very clear the voting choice you intend to vote.
3. To vote for a named candidate, completely fill the oval to the left of your choice. To vote for a write-in candidate, completely fill the oval to the left of the words "Write-in" and legibly print at least the first and last names of an eligible write-in candidate in the write-in area to the right. Vote like this:



WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges, or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. Ballot questions referred by the general assembly or any political subdivision are listed by letter, and ballot questions initiated by the people are listed numerically. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.

**BALLOT ISSUE 2C**

SHALL THE CITY OF FORT MORGAN TAXES BE INCREASED BY AN ADDITIONAL CITY SALES AND USE TAX AT A RATE OF ONE (1%) PERCENT TO BE ADDED TO OTHER APPROPRIATIONS BY CITY COUNCIL TO PAY THE COSTS OF STREET, ALLEY, AND RELATED INFRASTRUCTURE IMPROVEMENTS AND MAINTENANCE, COMMENCING ON JANUARY 1, 2018, IN AN AMOUNT OF UP TO TWO MILLION FOUR HUNDRED THOUSAND DOLLARS (\$2,400,000) ANNUALLY IN THE FIRST FISCAL YEAR AND BY WHATEVER ADDITIONAL AMOUNTS ARE RAISED ANNUALLY IN EACH SUBSEQUENT YEAR; AND SHALL THE FULL PROCEEDS OF SUCH TAXES AND ANY EARNINGS THEREON BE COLLECTED, RETAINED, AND SPENT, AS A VOTER-APPROVED REVENUE CHANGE WITHOUT LIMITATION OR CONDITION, AND WITHOUT LIMITING THE COLLECTION, RETENTION, OR SPENDING OF ANY OTHER REVENUES OR FUNDS BY THE CITY OF FORT MORGAN UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION?
